3.1 INTRODUCTION:

The Trichur Co. Operative Spinning Mill was commissioned during 1986 with an installed Capacity of 12000 spindles with LR DJ 50 Ring Frames and MMC Ring frames. During 1993 to 1995 period the mill was increased its capacity to 25104 by installing LR G5/1 Ring Frames which are included in the category of state of art technology. During 2000-01 a modernization was taken place and brought in 4 Nos. Trumac Cards and Sussen Asia Ring Frames by replacing MMC Cards and DJ 50 Ring Frames respectively, with that the spindle capacity was to 24288 due to insufficient fund. During 15-16, 7480 spindles of out dated Spindles were removed for modernization and the present capacity is 16128 spindles. New 9216 spindles were installed during the year 2020. Hence the final capacity will be 22320 Spindles. During 2010-11 a Hank Yarn project has been commissioned to cater yarn to Hand Looms through National Hand Loom Development Corporation.

On completion of expansion project and renovation of machinery the mill be capable of producing good quality yarn and can cater a part of yarn requirement of handlooms in Kerala. The mill can make good revenue income which results and it will turn around to a profit-making unit. Now planning to complete the ongoing Project before the end of Aug 2021.

3.2 Back Ground:

Currently TCSM Ltd is producing 60S PC Yarn and after the completion of the Modernization Project, planning to manufacture 62S and 80S, Autoconed Cotton Yarn in Carded and Combed. Also planning to produce Single and Doubled yarn as well as in cone and Hank form. The Mill is able to produce the required quality and quantity of Yarn in various Counts which is demanded by the Market. In a Competitive market, it is very difficult to reach all the buyers in limited time and this is the main reason to call EoI for DEPOT AGENTS to sell the yarn producing by TCSM Ltd to a particular State or all over India.

4.0 Aims & Objectives:

The objective of this is to find out the interested and genuine **DEPOT AGENT** in India so that the time and huge resources required to reach them can be eliminated by providing an opportunity for interested **AGENTS**.

5.0 EOI Tender Form Cost

A non-refundable Tender form cost of **Rs. 5000/- (Five Thousand only) + GST 18% is payable ie; Rs.5900.00 (Five Thousand Nine Hundred only) through E-tender mode. Bids received without or with inadequate EoI tender form cost will be summarily rejected.**

**Instruction to Bidders – Important points while making
online payment for e-Tenders**

Bidders, while participating in online tenders published in Government of Kerala's e-Procurement website (www.etenders.kerala.gov.in), should ensure the following:

- i. **Single transaction for remitting Tender document fee and EMD:** Bidder should ensure that tender document fees and EMD are remitted as one single transaction and not separate. Separate or split remittance for tender document fee and EMD shall be treated as invalid transactions. **(Only Tender document fee is applicable)**
- ii. **Account number as per Remittance Form only:** Bidder should ensure that account no. entered during NEFT remittance at any bank counter or during adding beneficiary account in Internet banking site is the same as it appears in the remittance form generated for that particular bid by the e-Procurement system.
