PAYMENT TERMS

90% Payment will be given on successful completion of each machine as pro rata basis with a performance guarantee of 3 Months and the remaining 10 % will be disbursed only after 3 Months of completion of work. However an advance up to 25% can be claimed by the contractor during the work.

INSPECTION

The Contractor is entitled to make his own arrangements for inspection of the site before submitting Tender. The parties are requested to contact our Mill In Charges, for facilitating and coordinating the site inspection. It will be presumed that all offers have been submitted after having duly inspected the Machines meant for erection.

SCOPE OF WORK:

The contractor will provide assistance as and when the new machinery ordered is arrived at site and ready for erection. The erection work will be as per the direction of the Erection Engineer of the Machinery supplier. The work should be carried out till the Erection Engineer satisfies the work. The time of work may be extended as per the direction of the Engineer . The erection and servicing includes Mechanical, Electrical works of entire machines.

WORK FORCE

The Contractor should arrange the labours and the Mill have no responsibility for their accommodation and other facilities. Also the Contractor should pay the ESI, EPF and other amount applicable to the prevailing rule of Govt. The Mill will deduct this amount from the payment to the Bidder. If any exception needed for remittance of ESI and PF, the required documents are to be submitted for approval.

PENALTY

Withdrawal of tender at any time after acceptance, failure to execute the contract within the scheduled time, shall constitute a breach of contract.
