Tenders are invited for empanelling of sellers from across India for the supply of Cotton Bales (29 mm to 34 mm) on regular basis to the Mills under the Ministry of Industries and Commerce, Department of Industries, Government of Kerala. UNDERLYING OBJECTIVE

The objective of PRICO MILLS is to appoint of Sellers from across India for supplying Cotton Bales (29 mm to 34 mm) on regular basis to the Priyadarsini Co operative Spinning Mills Ltd., Meenadom P O, Kerala. 686516

The Appointed would have following key objective –

1. Supply of Cotton as per the requirement of the Priyadarsini Cooperative Spinning Mills Ltd on regular basis.
2. Procurement of quality cotton for manufacturing Cotton Yarn Carded / Combed / Compact with reasonable market price.
3. To enjoy the possible credit facility with reasonable market price prevailing.
4. To be governed by PRICO MILLS Purchase Policy and as modified from time to time.

SCOPE OF WORK FOR SELECTED AGENCY

The scope of work for appointed Agency is mentioned below but not limited to the following:

1. Time is the essence of the contract. The delivery should be made as per the schedule given by the buyer. In case of delayed deliveries the buyer reserves the right to accept or reject the contract.

2. If the goods supplied are not in conformity with the properties stipulated in the contract, the buyer is entitled to reject the same at his option. The goods so rejected shall be retained with the buyer at the risk of the seller. The test results obtained in buyer's laboratory alone will form the basis for passing/rejection.
3. The weighment will be done at the Mills in the presence of Seller's representative.
4. The buyer and seller are liable to make good the losses, if any, to be sustained by either of them on account of breach of contract.
5. In case of failure to supply the entire contracted quantity within the time limit specified, the buyer can withhold payments related to supplies, if any, already received. Failure to supply the entire contracted quantity will be considered as disqualification, resulting debarring from the next three consecutive cotton purchases.
6. Jurisdiction in respect of this contract is restricted to Kottayam Courts only.
7. In case of any downward variations in the test properties of the supply sample as compared to the quality specifications ordered for in the purchase contract (purchase order), quality allowance will be deducted from the contracted price at the rates fixed in the cotton passing norms mentioned in this purchase order.
8. In case the supply is not effected within the time limit agreed upon the Buyer reserves the right to cancel the contract without further notice.
9. Colour and grade should be good.
10. The moisture content % is found exceeds the prescribed limit will be deducted in proportion by weight of the supplied cotton.
11. Cotton passing norms for claiming quality allowance shall be as under

PRICO MILLS

1. Premium can be given in the case of 2.5% span length ,50% span length ,strength and trash on Favorable (upward/downward) deviation from CD%(i.e.; 1%CD,3%CD and 12%CD respectively) by an amount of 1% basic value.
2. Total premium will be reckoned for set off against total allowances except trash allowance.
3. In case total premium exceeds total allowance, the passing rate will be limited to the contracted price.
4. If CD% exceeds the above mentioned maximum limits, such cotton will be rejected.
5. Moisture content of the received cotton shall be verified at mill level immediately, and the excess moisture content (than the ordered) be deducted from weight for calculating the invoice quantity. (Consequently moisture will not be tested at SITRA /CARDT hereafter).
