Bidders are requested to **submit the tenders on or before 09.08.2023, 2:00 PM** adhering to the technical specification and necessary supporting documents by indicating the highest rate, in the name of Managing Director, the Quilon Co-Op: Spinning Mills Itd, Karamkodu. P.O, Chathanoor, Kollam- 691 579 and the tender will be opened on 10.8.2023, 10:00 AM.

To participate in the quotation, the bidders are to make refundable Earnest Money Deposit (EMD) and tender form cost (not refundable) as follows:

RULES FOR REMITTING TENDER FEE & EMD:

TENDER FEE: Rs. 250/- to be remitted directly to the mills before collecting the tender form. For those who collect the form through e-mail the payment will be made to the mills before submitting alternatively take separate DD in favour of the mills along with the tender.

<u>EMD</u>: **Rs. 2000**/- to be remitted directly to the mills before collecting the tender. For those who submit tenders through speed post/registered post, separate DD in favour of the mills along with the tender.

The prospective bidders (venders/ suppliers) may contact our Managing Director, Shri. Umesh Krishnan, (Ph: 09446320156) / Technical Officer Shri. Manchu Roy. N.P, (Ph: 09400622826) for clarification on details of payment and submission of tenders.

Terms and Conditions are as follows:

- The bidder shall carefully and thoroughly study and obtain all clarification on relevant details regarding prices and provisions necessary for successfully carrying out the supply as per the tender documents. No claim/ objections will be entertained at a later date on account of lack of clarity/misrepresentation of any data.
- 2. Bidders are required to quote only for the items mentioned in the Notice Inviting Tender (NIT).
- 3. All taxes will be applicable as per the norms.
- 4. The bidders are expected to carry out the sale of item as per the specifications, terms and conditions of NIT.
- 5. Bidders are required to their quote for tenders invited in a single cover, containing the following.
 - a. Price bid showing rates against each item.
 - b. Proof of EMD and Tender form cost.
 - c. Specify whether excluding taxes.
- 6. Successful bidder should provide necessary machineries and equipment's for the above work.
- 7. The supplied material should be guaranteed for performance for a minimum period of 12 months from the date of completion.
- 8. The successful bidder should be ready to do the work within two weeks after awarding the confirmed purchase/ work order.
- 9. QCSM shall have no responsibility for any technical issue / delays from the bidders end for non-receipt of tenders send through post/ or any other means.
- 10. The contract will be awarded to the bidder whose bid is the highest (H1), at the negotiated rate, subject to the condition that the price is comparable with market price and bidder has the capacity and resources to carry out the contract effectively and timely.

- 11. Quotations are not properly filled, or with incorrect calculations and generally not complied with conditions, will be summarily rejected.
- 12. "Specification" shall mean all technical specification of the product/items/equipment.
- 13. QCSM reserves itself the authority to reject any or all quotations received by assigning the reasons therefore.
- 14. The EMD of the unsuccessful bidders will be returned by the mills after completing tender formalities.
- 15. The bidder should deposit within 7 days after receipt of the communication of acceptance of the tender, a security deposit of 25% of the value of the final rate plus 18% GST after adjusting EMD by means of DD/RTGS in favour of the Quilon Co-Op: Spinning Mills Itd payable at Chathanoor and this amount also will not carry any interest. A contract in agreement has to be signed by the buyer in stamped paper of value of Rs.200/- and above.
- 16. This amount will be adjusted while making the balance amount of taking delivery payable by the successful bidder.
- 17. The security deposit is not paid in time ie, within 7days, the EMD will be forfeited and tender will be rejected without any reference to the buyer and the management can cancel the order and dispose the machines at the bidders cost and the loss will be recovered from the bidder.
- 18. The quotation shall remain valid for acceptance for a period of 90 days from the date of submission.

INSPECTION:

The buyer is entitled to make his own arrangement for inspection of the machinery. The parties are requested to contact mill in-charge for facilitating and coordinating the site inspection. It will be presumed that all offers have been submitted after having duly inspected the items meant for sale.

PAYMENT CONDITIONS:

The balance amount for the value of the machinery for sale including 18% GST should be remitted by means of DD/RTGS drawn in favor of The Quilon Co-Op: Spinning Mills Ltd, payable at Chathanoor within 30 days of communication of the acceptance of tender.

DELIVERY:

The buyer should take delivery of the machinery after remitting the full value within 60 days from the date of receipt of communication of the acceptance of tender or 30 days of final payment made. Delivery will be between 10.00 am to 4.00 pm on specified working days, which will be intimated in due course. Buyer should make their own arrangement for taking delivery of the item.

TRANSPORT:

All arrangements and licenses and approvals required for taking delivery of the machine should be done by the buyer and all expenses on this account shall be borne only by the buyer.
